

LGBTQIA2S Religious Exemption Form Statements and FAQs

Q: The LGBTQIA2S Opt-out Form was created by right-wing extremists.

A: No. The LGBTQIA2S Opt-out Form was created by parents who follow the U.S. Constitution.

Q: LGBTQIA2S is not a religion.

A: Yes, it is. It fulfills the EOCC definition of a religion.

And the Acronym LGBTQIA2S ends with "Spirit". Spirituality = religion.

Google and Apple put it on my calendar in June like they do with religious holidays.

Q: LGBTQIA2S is not a religion.

A: Yes, it is! It is such a deeply held belief that Nebraska state senators filibustered the entire 2023 Nebraska legislative session. You say if we don't agree with you, children are going to die. This statement of belief of 'life and death' fulfilled the EOCC definition of a religion.

Q: Transgender is different from 2 Spirit.

A: No, it's all part of the LGBTQIA2S religion. The religion even has a flag.

And they have a whole month in June where the religion is celebrated EVERYWHERE.

Q: You're mixing up separate things.

A: No, YOU say that under intersectionality these are all related.

Q: Transgender is not a religion.

A: Then scientifically and objectively prove that a person is trapped in a body that doesn't match what they think their "gender" is. (Asking the person what they think isn't objective, it's subjective.)

Q: You just hate LGBTQIA2S people.

A: Nice try. You don't know what I think, and it doesn't matter what I think. The law says no religious indoctrination in public schools. That's the issue.

Q: You're a fascist.

A: No, but you sound like a left-wing Communist.

Q: You just want to erase and genocide LGBTQIA2S people.

A: No, I don't want you forcing your religion onto my child in public schools. That's illegal.

Q: Children will die if we don't teach them LGBTQIA2S.

A: Christians believe we will eternally die if we don't believe in Jesus. But that doesn't mean we can teach it in public school. You can't teach your religion, either.

Q: You can't stop a gay student club in public school.

A: I am saying you can't indoctrinate my child with a religion that I don't want them to be indoctrinated with, any more than I can force your child to join Fellowship of Christian Athletes.

Q: This is just about Christians hating LGBTQIA2S.

A: No, this is about the Supreme Court ruling that you can't indoctrinate my child with your religion in public school.

Q: You're causing harm to LGBTQIA2S students by not using their pronouns.

A: No. Pronouns are only used when you're not in the presence of the people you're referring to, not when you're talking to them directly. When you're in a person's presence, you just call them by their name, or "you". Fake pronouns are just virtue signaling to everyone else to show that you're woke.

Q: Some states, like New York, say it's illegal if you don't use a student's preferred LGBTQIA2S pronouns.

A: So, you even have blasphemy laws like a religion!

Q: It's not happening in our school!

A: Great! Then there should be no problem in you signing my religious opt-out form!

Q: You are interfering with the Human Rights Campaign, Planned Parenthood, the Trevor Project, SIECUS and other pro-LGBTQIA2S organizations who have a right to free speech.

A: All of the LGBTQIA2S nonprofits like the Sherwood foundation, the Human Rights Campaign, Planned Parenthood, the Trevor Project and SIECUS are violating the Establishment Clause in public schools by teaching your religion.

All of them should have their tax-exempt status revoked!

Q: We're not a religious organization, we are political organization!

A: Even more reason to revoke your tax-exempt status!
Religious organizations can't advocate for politics!

Q: Nobody else, and especially the young people, agree with you and are totally inclusive to LGBTQIA2S issues. You're in the minority and on the wrong side of history.

A: It doesn't matter whether I'm in the minority or majority, the Establishment Clause forbids you from indoctrinating public school students with your religion.
